In consideration of being permitted entry to and/or use of the "Premises" of Army Aviation Shotgun Club Skeet/Trap and five Stand facilities for whatever purpose, including but not limited to, use of firearms and/or by him or her and/or another, and with full knowledge that firearms and/or other weapons are used and discharged on the "Premises" of Army Aviation Shotgun Club Skeet/Trap and five Stand facilities, the Undersigned hereby agrees to the following: The Undersigned agrees to indemnify, hold harmless, and defend the Army Aviation Shotgun Club, its officers, agents and assigns, for and from any and all fault, liability, costs, expenses, claims, demands and/or lawsuits arising out of, related to, or in any way connected with any and all actual or alleged acts or omissions of the Undersigned in the course of the Undersigned's presence on and/or use of the Army Aviation Shotgun Club's premises, including but not limited to any range, building, facility and land. The Undersigned further waives, for himself/herself, and his or her heirs, next of kin, assignees, personal representative, administrator and executors, and any and all rights and claims for damages, losses, costs, demands and any other actions or claims whatsoever, which he or she may have or which may arise against the Army Aviation Shotgun Club, its officers, agents or assigns, including but not limited to, any damages to the Undersigned's property, illnesses, injuries, including mental or emotional distress, and any other damages, including death, suffered by the Undersigned, which may in any way whatsoever arise out of, be related to, or connected with the use of firearms and/or any other weapons on the "Premises" of the Army Aviation Shotgun Club, by the Undersigned and /or another. The Undersigned, for himself/herself and his or her heirs, next of kin, assignees, personal representative, administrators and executors, expressly releases the Army Aviation Shotgun Club, its officers, agents and assigns, from any and all such claims and liabilities, included but not limited to, any claim of actual or alleged negligence on the part of Army Aviation Shotgun Club, it's officers, agents, servants or assigns. The Undersigned acknowledges and agrees that the use of firearms is an inherently dangerous activity. The Undersigned expressly agrees that this release and agreement is intended to be interpreted as broadly and inclusively as permitted by law and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provision shall not be impaired. No remedy conferred by any of the specific provisions of this agreement and release is to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity. The election of any one or more defenses hereunder by Army Aviation Shotgun Club shall not constitute any waiver of Army Aviation Shotgun Club's right to pursue other available defenses.
